The Company may conduct the Contest concurrently and simultaneously on several participating radio stations owned and not owned by the Company, and in various States, and the Company may add or remove participating stations or change call letters of any participating station at any time during the Contest as announced on the affected station. Participating stations are listed above.

1. Description of Contest/Participation.

- A. Dates of Contest: The Contest will begin and end on Thursday January 22, 2009 at 5:00pm until 8:00pm PST. NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING. Void where prohibited. Odds of winning depend upon the number of participants.

- C. Winners will be chosen randomly by hand drawing from the in-person entries between 5-8pm; only complete and correct entries are valid. ENTRANT MUST BE PRESENT TO WIN.

E. Prize(s). The prize(s) that may be awarded to the eligible winner(s) are:
